Village Health Care is open for visitation. Additional precautions to reduce the risk for transmission of the COVID-19 virus remain in effect.

- Guests may visit inside or outside without scheduling an appointment.
- The facility has a limited number of outdoor visitation spaces, persons who chose to visit without reserving an outdoor visitation area may experience a wait.
- There are no longer any restrictions on the length of visitations, guests may visit a resident for as long as they chose.
- There are currently no restrictions on the number of visitors a resident may have at one time. The facility is still required to ensure guests can socially distance while in the resident's room. If the resident experiences a high volume of visitors at one time, guests may have to wait until other visitors to the resident step out of the room in order to maintain the required social distancing.
- Guests of any age may visit as long as they can comply with the infection control requirements including use of a face-covering or mask.
- All guests must enter through the main entrance of the facility for screening. Guests are not permitted to enter the households through the living room doors.
- Guests who have tested positive for COVID-19 in the preceding 14 days are not permitted entry to the facility.
- Guests who have had close-contact exposure to a person with COVID-19 in the previous 14 days are not permitted entry.
- Guests with respiratory symptoms or a temperature of 100.0 or greater may not be permitted entry until the symptoms have resolved.
- All guests are required to wear a face-covering. Face-coverings or masks are required to enter the
 facility and must be worn consistently when in facility hall ways or common areas. If the vaccinated
 resident and vaccinated guest chose to remove masks while in the resident room, the visitor must
 reapply their mask before entering the hallway or common spaces.
- Social distancing of at least 6 feet is required at all times.
- All visitors should perform hand hygiene with alcohol-based hand sanitizer prior to the visit and frequently throughout the visit.
- All indoor visitors must travel directly to their resident's location following screening and directly to the exit upon departure. Visitors may not visit other residents or walk about the facility. Visitation may not occur in hallways or facility common areas.
- Guests will not be permitted to dine with residents at this time, guests are required to wear face coverings or masks continuously during the visit.
- Guests visiting a shared room are required to wear a facemask for the duration of the visit if the room is occupied by a roommate. The guest should socially distance at least 6 feet from the roommate and the privacy curtain must be pulled between residents.
- Guests visiting residents under quarantine or transmission-based precautions will be required to wear
 a facemask. The resident should wear a facemask if tolerated. Guests are advised if they chose to visit
 a resident in quarantine or under transmission-based precautions that they may be exposed to and/or
 contract the COVID-19 virus. Guests will receive recommended precautions to follow during the visit.
 The facility will provide personal protective equipment.
- Visitors are required to report if they should develop signs or symptoms of respiratory illness or test positive for COVID 19 within 14 days of their visit to the facility.
- The facility cannot make accommodations for guests to participate in large gatherings or parties.
